Legislative Affairs

VETERAN LEGISLATIVE AFFAIRS

Hot topics need resolution by this 112th Congress:

1. The President's proposed budget that includes exorbitant changes in TRICARE premiums over the next 5 years and copays and prescription drug copays.

- **Impose Premiums for TRICARE Standard** (up to \$250 per family), and hikes in deductibles, (up to as much as \$580 per family, **a 193% increase**),

- **TRICARE Prime premium hikes** (up to as much as \$2,048 per family, **a 394% increase**),

- **Impose Premiums for TRICARE for Life** (up to as much as **\$475 per individual**)

- **Means testing or tiering of premiums** for TRICARE Prime and TRICARE for life,

- **Mail order and retail pharmacy prescription drug copay increases** from no cost now up to as much as \$9 for Generics, from \$9 now up to as much as \$34 for Brand Names (**a 378% increase**), and from \$25 now up to as much as \$66 for Formularies (**a 264% increase**)

2. "Doc Fix" Legislation: Because of a flawed "Sustainable Growth Rate" (SGR) formula adopted in the balanced budget Act of 1997, and first addressed in 2002 for CY 2003, **scheduled cuts in Medicare and Tricare fees paid to Doctors has been deferred** by Congress annually for the past 10 years.

That cut could be as much or more than 30% **beginning 1 Jan 2013** because Congress has refused to address a permanent fix for this problem over the past 10 years. If this happens, **more doctors will refuse to accept Medicare and TRICARE patients.**

BUT THERE IS SOME GOOD NEWS - H. R. 1627; "Honoring America's Veterans and Caring for Camp Lejeune Families Act of 2012". It is a multifaceted bill that in part prohibits disruptions of funerals of members or former members of the Armed Forces. It passed by unanimous consent in the Senate on 18 Jul, was agreed to by voice vote in the House on 31 Aug, and was sent to the President on 3 Aug and was **signed into law on 6 Aug 2012.**

It is now unlawful nationwide for any person to engage in any disrupting activity during the period beginning 120 minutes before and ending 120 minutes after any part of a funeral activity on or near the boundary of the residence, home, or domicile of any surviving member of the deceased person's immediate family; or within the boundaries of the location where a funeral takes place; or within 300 feet of the road, pathway, or other route of ingress to the location of the funeral; and within 500 feet of the boundary of the location of the funeral.

It prohibits willfully and without proper authorization impeding or tending to impede the access to or egress from the funeral location and from willfully making or assisting in the making of any noise or diversion that is not part of such funeral and that disturbs or tends to disturb the peace or good order of such funeral with the intent of disturbing the peace or good order of such funeral.

Such links include "Heroes to Hired", Indeed and "azjobconnection" to augment the reduced coverage in other areas of Arizona.

- c. TOPS Coordinators are vital to the success of the various chapters as a “value added” offering. It is recommended that each chapter look to the membership to find someone willing to go out and visit the local companies, make them aware of the benefits of being able to hire dedicated, highly qualified professionals who already have the work discipline necessary for the work force. These professionals do not require, most often, any training and can be expected to “hit the ground running.”

National MOAA has published a new interactive publication pamphlet for personal affairs. It is called [Family Matters: A Personal Inventory for Peace of mind](#). This booklet can be found on the National MOAA website, along with other great pamphlets at <http://www.moaa.org/infoexchange/>

The Chapter PA Officer should hold an annual Personal Affairs workshop (held at a monthly meeting) and they should make a special effort to have their members spouse's attend. The spouse's are usually the ones with the most relevant questions that need answering.

The individual Chapters PA Officer should also have a reference library at home to use as guides to help answer questions and use as a resource for helping with survivor benefits. The list of reference material can be found in MOAA's Policy and Procedures manual under appendix J.

The Chapter PAO can call National MOAA at 1-800-234-622 to obtain these copies for their individual personal reference library.

The PA Officer should always send out a survivor package which contains the booklets Survivors checklist, Turning the Corner, TAPS along with a list of local resource phone numbers along with a condolence letter to all survivors when a member passes away. These booklets and phone numbers really **do** help answer survivors questions and help them negotiate the obstacles following the loss of their loved ones.

We have a Personal Affairs page on our Council website that has all these booklets and resource numbers available to your PAO and our members.

ESGR, US Chamber of Commerce and US Dept. of Labor are conducting Mega Guard, Reserve, and Veteran Hiring events throughout the Country. 400 events are planned for this year. Southern Arizona Hiring our Heroes Career Fairs, will be held in Sierra Vista, Yuma, Nogales, and Tucson on September 27, 2012.

The H2H, Hero 2 Hired, Mobile Job Center toured Arizona with stops in Flagstaff, Prescott, Phoenix, Tucson, Sierra Vista, and Yuma. www.h2H.jobs is replacing several internet job sites. H2H Aps are available for Android and Apple Smartphone. The H2H Mobile Job Center was showcased at the opening of the Kino Veteran Workforce Center Aug 15 in Tucson. The Mobile Job Center also visited the Air Force Reserve Command Yellow Ribbon and Re-integration event Aug 18 in Oro Valley.

JUL 12 was a tremendously successful military hiring event at the American Legion Post 36, Tucson, AZ. We connected 30 employers with 277 job seekers from the Tucson military population. Channel 4 set up a tent in the parking lot and covered the event twice on the evening news. 109 employers and over 400 service members have signed up for the H2H Job Fair in Scottsdale August 21.

ESGR continues to mediate disputes and provide information to Employers and Service Members regarding Uniformed Services Employment and Reemployment Act (USERRA). So far this year 201 request for information have been handled by telephone in addition to formal complaints.

This year, 663 Arizona employers have signed a "Statement of Support" pledging to support the men and women who give freely of their time to take on the additional obligation to serve as members of the Guard and Reserve.

Two fellow MOAA members were honored recently, Cmdr. John Chernoski received Arizona Outstanding Ombudsman Award for 2012, and Lt Col Darren Venters was named Arizona Military Outreach Coordinator for 2012.

Mr. William Valenzuela, Chairman Emeritus, Arizona Committee ESGR passed away after a very short illness July 8. Bill was the mainstay of the organization for many years. He will be sorely missed by all. The 162nd Fighter Wing flew the "missing man" formation with F16 during Bill's service.

Mr. Scott Essex, AZ ESGR State Chairman, announced the selection of Mr. Tim Williamson

to be the new Chairman. Mr. Williamson will bring a wealth of knowledge and experience to the Arizona Committee with his numerous business and community connections.

Mr. Williamson's background includes, President of American Steel Corporation, past President and current Board Member of the Phoenix Air National Guard PANG Patriots, member of the 162nd Fighter Wing Minutemen Committee, and a Greater Phoenix YMCA Metro Board Member. Mr. Williamson has a proven record of supporting numerous military and community support organizations. He will assume the duties of the Arizona Employer Support of the Guard and Reserve State Chairman on October 1, 2012.
